1 Water & Reducing Single-Use Plastic - RMF provides water filling stations to schools and public spaces, providing clean water while eliminating single use plastic water bottles. In 2018 RMF donated and facilitated the installation of multiple water filling stations in Southern California schools and also donated reusable water bottles. Rob Machado, a professional surfer and role model, visited schools to educate students and motivate them to reuse. RMF helped provide and staff the Water Oasis (free water filling stations) at the Switchfoot Bro-Am, a major surf/music event at Moonlight Beach, CA, estimated at over 15,000 attendees. Collectively, by using the water refill stations, attendees and RMF prevented the use of over 3,100 single-use plastic bottles, thus keeping them out of landfills and the ocean.	42,702
2 Trash and Recycling - RMF provides trash and recycling solutions at beaches, schools and surf events to protect waterways and save recyclables from entering the landfill. In 2018, RMF hosted regular San Diego beach cleanups.
