The Fund makes grants to support research in topics relevant to the mission of the NBME. The initial sum of \$5,000,000 was invested and professionally managed with the goal of maintaining the corpus of the Fund over time while providing total annual grants up to 5% of the trailing three-year average of the fund balance. As with all NBME invested funds, the Finance Committee monitors performance and recommends to the Executive Board any changes to the principal balance of the Fund. THE STRATEGIC EDUCATOR ENHANCEMENT FUNDIn 2017, NBME established the Strategic Educator Enhancement Fund to foster professional development for its community of volunteers and other stakeholders. The initial amount of \$20,000,000 was designated within NBME's investments as a quasi-endowment fund. The maximum annual authorized disbursement from the quasi-endowment fund for 2017 through 2019 is an average of \$600,000 per year. Beginning in 2020, the maximum annual disbursement in any year will be equal to 5% of the average of the trailing three-years ending balance of the investments.

Accordingly, there is no provision for income taxes reflected in the accompanying consolidated financial statements. However, NBME is subject to federal unrelated business income tax which is taxed at corporate income tax rates. NBME had unrelated business taxable income (UBTI) of \$48,000 for the year ended December 31, 2017 associated with the operation of a debt-financed commercial rental property. Accordingly, NBME had net operating loss carryforwards of \$1,464,000 and a related deferred tax asset of \$307,000 as of December 31, 2017, which was fully reserved due to the uncertainty of the realization of the loss. Effective January 1, 2018, the Tax Cuts and Jobs Act of 2017 enacted new provisions in the IRC that subject amounts paid or incurred by employers to provide qualified transportation fringe benefits to employees to unrelated business income tax. Accordingly, NBME reversed the beginning-of-the-year deferred tax asset reserve of \$307,000 and recognized an \$110,000 unrelated business income tax charge associated with UBTI of \$525,000 for the year ended December 31, 2018. In addition, NBME has net operating loss carryforwards of \$939,000, which expire between December 31, 2029 and 2036, and a related deferred tax asset of \$197,000 as of December 31, 2018. The deferred tax asset is included in other assets in the Consolidated Statements of Financial Position. NBME has no uncertain tax positions and there are no accruals for interest or penalties in the accompanying consolidated financial statements. Management believes that NBME is no longer subject to income tax examinations for years ended on or prior to December 31, 2014.

The purpose of the collaboration is to increase efficiency and facilitate NAVLE enhancements, drawing on the best of both organizations. The Health & Wellness Coach Certifying Examination is a collaborative program with the International Consortium of Health & Wellness Coaching. This new exam program is designed to assess competence in the field of health and wellness coaching. To date, over 1,800 health and wellness coaches have passed the certifying exam. OTHER PROGRAM SERVICES 5 NBME's International Programs unit provides students, graduate physicians, medical schools, and regulatory agencies with valid and reliable information regarding individual knowledge and overall curriculum effectiveness. The International Foundations of Medicine (IFOM) examinations represent a key component of NBME International Programs. The Clinical Science Examination (CSE) covers the core of clinical knowledge in medicine, surgery, pediatrics, obstetrics and gynecology, and psychiatry expected of students in the final year of undergraduate medical education. The Basic Science Examination (BSE) incorporates the common core of knowledge expected of students who have completed the preclinical curriculum and are about to begin study of clinical medicine.
