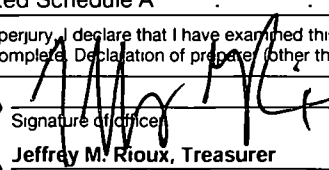

This change reflects the correct amount of net assets, which was incorrect only due to clerical error prior to 2012.

Part II, Line 24 - Other Assets - We had previously been showing an Endowment which is managed by the Adams County Community Foundation here in "Other Assets". After consulting with an accountant, it was recommended that we include this in Line 22, Cash, savings, and investments. We made that change in 2018.
