Eschaton supports educational efforts regarding the philosophy and practice of nonviolence by operating the Resource Center for Nonviolence, which runs its own programs and events, as well as manage a facility used by dozens of other community groups. Eschaton also supports other organizations around the country and the world that promote similar activities.

"The Boys Who said No" - production of a documentary film about nonviolent opposition to the Vietnam War particularly focused on opposition to the draft during this period. When released, thousands of people will view the film and learn about an important historical moment in American history. This film may also be used as part of a peace or nonviolence education curriculum.

4b (Code _____) (Expenses \$ 140,602 including grants of \$ _____) (Revenue \$ 598)

Resource Center for Nonviolence Program. The Center provides information regarding the philosophy and practice of nonviolence by offering educational programming through activities such as workshops, presentations, films and printed or digital information. There were 2,150 attendees at RCNV events. RCNV also has a youth program working in the schools and through independent events to promote nonviolence and civic engagement, which was attended by over 100 youth. Significant programming in 2018 included, 1.) a delegation to Selma, Alabama to work with the Nonviolence Reconciliation Center, 2.) national nonviolence trainers gathering, 3) multiple social justice focussed art exhibits, 4.) Santa Cruz Reel Works Film Festival, an annual film festival showing documentaries mostly with labor themes, held at local movie theaters and community centers, 5.) Santa Cruz Community Coalition to Overcome Racism, providing diversity workshops and activities to overcome racism and promote diversity.

Resource Center for Nonviolence Community Center In addition to its direct program contributions in support of nonviolence, the RCNV also operates a community center that serves as a resource for dozens of organizations and hundreds of visitors, for low cost or sometimes no cost (donated space for events and groups with limited funds). RCNV Community Center facility hosted over 550 events and meetings attended by over 8,500 people 98 different organizations used the Center for meetings and public programs.
