ME is a partnership of Good Samaritan Hospital Foundation and two area service organizations: Lifestages Centers for Women and Catholic Social Services of the Miami Valley. Through group prenatal care, the mothers meet in small groups of women with similar due dates to learn to care for themselves and their baby, complete regular pregnancy check-ups, and form a support network with other young mothers. Approximately 75 women were served in 2018.
