OUTREACH TO OUR MEMBERSHIP AND LOCAL SUPPORTERS AND THEIR BACKING OF SPECIAL EVENTS CONTINUED TO PROVIDE THE GREATEST SUPPORT TO THE FOUNDATION'S OPERATIONS. THE ARMY HERITAGE CENTER FOUNDATION CONTINUED ITS EFFORTS IN 2018 TO ADVANCE THE DEVELOPMENT OF THE U S ARMY HERITAGE AND EDUCATION CENTER (USAHEC), TO PROMOTE THE CENTER AS A TOURIST DESTINATION, AND TO ENHANCE ITS PROGRAMS AND OUTREACH. TO BETTER SUPPORT THESE EFFORTS, THE BOARD OF DIRECTORS REORGANIZED IN NOVEMBER 2018 BY REDEFINING COMMITTEE ROLES AND RESPONSIBILITIES. AS NOTED ABOVE, THE MISSION OF THE FOUNDATION REMAINED THE SAME. WHILE THE CAPITAL CAMPAIGN THAT WILL SUPPORT THE FUTURE EXPANSION OF THE HALL OF THE AMERICAN SOLDIER - A 30,000 SQUARE FOOT, 12 MILLION EXPANSION, CONTINUED, A TRANSITION IN THE LEADERSHIP OF THE U S ARMY HERITAGE AND EDUCATION CENTER SLOWED THE FOUNDATION'S ABILITY TO VALIDATE FUTURE REQUIREMENTS BASED UPON THE NEW DIRECTOR'S VISION. IN THE INTERIM, THE FOUNDATION UNDERTOOK A SMALLER PROJECT, THE CONSTRUCTION OF AN EVENT PAVILION, ON THE CAMPUS, TO PROVIDE A YEAR ROUND VENUE FOR OUTSIDE PROGRAMS. TO MARKET USAHEC TO THE TRAVELING PUBLIC, THE FOUNDATION CONTINUED TO SUPPORT A TABLET/MOBILE PHONE APPLICATION THAT ALLOWS TRAVELERS ON I-81 TO GAIN INFORMATION AS THEY TRAVEL THROUGH THE REGION. TO BROADEN OUTREACH, THE FOUNDATION BEGAN A WEEKLY E-BLAST PROGRAM TO PROMOTE USAHEC AND THE FOUNDATION'S PROGRAMS. FINALLY, THE FOUNDATION STAFF CONTINUED TO SUPPORT PROGRAMS AND EVENTS WHEN FEDERAL FUNDS OR EMPLOYEES WERE UNAVAILABLE. THE FOUNDATION ALSO CONTINUED EFFORTS TO ENHANCE USAHEC AND ITS PROGRAMS. ADDITIONALLY, THE FOUNDATION SERVED AS PROGRAM LEAD AND COORDINATED TWO FILM PREMIERS AND SPECIAL PROGRAMS FOR A BLACK HAWK DOWN - THE UNTOLD STORY AND THE WEIGHT OF HONOR. IN JUNE, THE FOUNDATION AGAIN HOSTED AT THE U S ARMY HERITAGE AND EDUCATION CENTER THE REGIONAL ARMY BIRTHDAY DINNER AND IN NOVEMBER, THE ANNUAL MEMBERSHIP RECOGNITION DINNER THAT HIGHLIGHTED THE SERVICE OF MIKE DURANT AND MATT EVERSMAHN, TWO SOLDIERS INVOLVED IN THE BATTLE OF MOGADISHU AND THE EFFORTS OF THE SPECIAL OPERATIONS WARRIOR FOUNDATION FOR THEIR SUPPORT TO THE FAMILIES OF FALLEN SPECIAL OPERATIONS SERVICE MEMBERS. THE TEST PROGRAM BROUGHT THE CADETS AND SCHOOL CADRE TO USAHEC FOR PRESENTATIONS ON THE RESOURCES THAT THEY CAN DRAW FROM THE COLLECTION TO SUPPORT THEIR UNITS ONCE COMMISSIONED AND THEN FUNDED LICENSED BATTLEFIELD GUIDES TO FACILITATE AND IMPROVE THE QUALITY OF THE STAFF RIDE EXPERIENCE FOR THE GRADUATING SENIORS. FULL EXECUTION IS PROGRAMMED FOR THE SPRING OF 2019. THE FOUNDATION'S ACTIVE ROLE IN WORKING WITH POTENTIAL DONORS OF ARTIFACT, MANUSCRIPT, AND LIBRARY COLLECTIONS WAS MAINTAINED. IN 2018, THE FOUNDATION FACILITATED MORE THAN 275 IN KIND DONATIONS TOTALING 166,281. AS A COMPONENT OF NATIONAL HISTORY DAY, THE STAFF ALSO CONTINUED ITS QUARTERLY TEACHER WORKSHOP PROGRAM IN 2018 AND ITS EFFORTS TO BUILD A COLLECTION OF SOLDIER STORIES ON THE FOUNDATION'S WEBSITE THAT ARE AVAILABLE AT NO COST TO USERS. THROUGHOUT THE YEAR, THE EDUCATION PROGRAM EXPANDED ITS INTERACTION WITH VETERANS. OUR PARTNERSHIP WITH CUMBERLAND VALLEY HIGH SCHOOL CONTINUED, AND IN 2018, WE PAIRED 14 STUDENTS AND VETERANS WHO PARTICIPATED IN THE VETERANS ORAL HISTORY PROGRAM. THE FOUNDATION'S "WALK WITH A VETERAN" PROGRAM GREW, AND MORE THAN 400 STUDENTS AND 50 VETERANS AND VOLUNTEERS PARTICIPATED IN THIS PROGRAM. FINALLY, THE VETERANS' CAF THAT BRINGS VETERANS OF ALL SERVICES AND ERAS TOGETHER TO ENJOY A MEAL AND SHARE STORIES OF SERVICE CONTINUED TO GROW. IN 2018, 11 VETERANS CAF PROGRAMS WERE CONDUCTED IN CENTRAL PENNSYLVANIA INVOLVING MORE THAN 350 VETERANS AND THEIR FAMILY MEMBERS. THE FOUNDATION'S MUSEUM STORE ONCE AGAIN SERVED AS AN ENHANCEMENT TO THE VISITORS' EXPERIENCE TO USAHEC. THE STORE STAFF CONTINUED TO TAILOR MERCHANDISE TO THE CLIENTELE AND TO SUPPORT SPECIAL PROGRAMS AND USAHEC LECTURES. BOTH THE NUMBER OF TRANSACTIONS FOR THE CALENDAR YEAR AND NET PROFITS DECLINED SLIGHTLY FROM 2017.
