## **Matching Gifts**

### **Who is eligible to apply?**

Any full-time employee or member of the Board of Directors of Textron is eligible.

### **How do I participate?**

Donor For each gift, you need to complete a gift request through ERIC. To access the form, click on the "Directory/Search tab" and then click on "Textron Corporate Giving/Matching Gifts" and follow the instructions. The recipient organization will receive an email from Textron's Matching Gift Department asking for verification of the gift. If all requirements have been met, Textron will match the gift.

### **How are gifts matched?**

Textron will match contributions between \$25 and \$7,500 per individual, per calendar year, to eligible institutions at a \$1:\$1 ratio, for a maximum Textron contribution of \$7,500. An individual may attain their \$7,500 limit by giving a one-time \$7,500 contribution or by making several smaller gifts. Gifts must be made directly from the employee's/director's own funds to approved institutions. Non-U.S. Gift Requests: Gifts made outside of the United States must be equivalent to a minimum of \$25 USD. All payments made to organizations located outside of the United States will be paid in the local country's currency.

### **How many different organizations can I donate to?**

You can donate to as many eligible organizations as you like and Textron will match your donations up to a maximum total of \$7,500 per year.

### **How is the annual donor limit determined?**

The annual donor limit is determined by the actual date of the donor's contribution to the recipient organization. For example, if you make a donation of \$5,000 on Dec 31, 2018 to an eligible institution, and you submit your matching gift transaction in January 2019, the matching gift award will count toward your 2018 limit.

### **What types of contributions are matched?**

Contributions must be paid either by check or negotiable securities that have a publicly listed market value. The value of securities will be determined based upon the closing market price on the date of the gift. To be matched, gifts must be paid, not merely pledged. The Textron Charitable Trust reserves the right, for any reason and at any time, to decline a grant to any institution, terminate a person's participation in the Matching Gift Program or suspend, terminate or modify the Matching Gift Program without liability to any individual or organization.

### **When are gifts matched?**

Requests are processed as they are received. Incorrect or incomplete forms are delayed while the required information is obtained.\* Payments are made quarterly. Applications received by Textron by March 1 will be paid by March 31; applications received by June 1 will be paid by

June 30; applications received by September 1 will be paid by September 30; and applications received by December 1 will be paid by December 31. \*Expect longer delays in the process and payment for requests made to organizations located outside of the United States due to the stringent validation process required by the U.S. IRS to ensure that non-U.S. organizations comply with and are equivalent to a U.S. 501(c)3 charitable organization.

**Which organizations are eligible?**

Organizations located in the United States must be recognized by the Internal Revenue Service (IRS) as tax-exempt and designated a public Charity under Section 501(c)3 of the IRS code.

**What gifts are not eligible?**

Textron will NOT contribute matching funds for:

- Requests received more than 90 days after the date of the gift
- Part-time, temporary and retired employees
- Gifts to organizations that are not tax-exempt under section 501(c)3 of the Internal Revenue Service Code or are otherwise ineligible
- Membership dues
- Subscription fees for publications
- Tickets or merchandise purchases
- Charitable contributions made as part of a United Way or employee giving campaign
- Charitable contributions made via payroll deduction
- Payments that cover the cost of services, tuition, books or student fees
- Donations to seminaries and theological schools
- In-kind services, materials, supplies or pledges
- Gifts made with funds provided to the employee for donation purposes by other individuals (i.e. pooled/group funds)
- Gifts made to churches, synagogues, mosques and other institutions that are primarily religious in nature.

**What is a 501(c)3?**

A 501(c)3 is a section of the U.S. Federal Tax Code which establishes the criteria for tax-exempt charitable organizations. An organization must have 501(c)3 status (be tax-exempt) in order to receive matching funds. Note that not all 501(c)3 organizations qualify for the program.

**How will I know my request has been received/processed?**

You will receive an automated email upon receipt of your request and another email once the request has been processed.

## **FUNDING CYCLE**

In the calendar year, Textron will accept and review requests during two funding cycles. In order to be considered during these cycles, grant request must be received by March 1, and September 1.

## **HOW TO APPLY FOR A GRANT**

Textron considers grant requests from organizations that most closely fit our philanthropic priorities and will review only one request per organization during a 12-month period. Multi-year commitments will be considered but are limited. Organizations interested in applying to Textron are encouraged to use the Associated Grant Makers (AGM) Common Proposal Form. Multiple grant applications are not required. Please note that only complete applications will be reviewed and considered for funding.

### **2020 Textron Scholarship Program**

**For U. S. high school junior (11th grade/third year) students who will be completing or leaving high school and entering college in the fall of 2020.\***

### **The Textron Scholarship Program**

This scholarship program was established by Textron Charitable Trust for sons and daughters of Textron Inc. employees. The annual competition is conducted through the National Merit Scholarship Program by National Merit Scholarship Corporation (NMSC), an independent, not-for-profit organization. NMSC's purposes are (1) to identify and honor exceptionally able high school students and (2) to provide a system of services for corporations, foundations, and other organizations that wish to sponsor college undergraduate scholarships for outstanding students who interest them. All aspects of the selection of winners and the administration of their awards are handled by NMSC.

### **Who is eligible?**

Only high school students who are sons and daughters full-time employees of Textron Inc. or its business units can compete for these scholarships. Such students also must meet all requirements for participation in the National Merit Scholarship Program that are published in the *PSAT/NMSQT Student Guide* which is updated annually and distributed to students through their high schools.

To participate in the program, students must take the qualifying test, the Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT) during the proper high school year. In general, students who spend the usual four years in grades 9 through 12 must take the PSAT/NMSQT when they are in their third year (grade 11/junior year). The *PSAT/NMSQT Student Guide* explains these and other requirements for the competition, gives detailed information about the test (including sample questions and a complete practice test), and describes the scholarship programs NMSC administers.

\* Students who plan to leave high school a year (or more) early to enroll in college full time should refer to the *PSAT/NMSQT Student Guide* (or contact NMSC) about when to take the qualifying test.

### **How does a student enter the 2020 Textron Scholarship Program?**

To enter the competition for Textron Scholarships to be awarded in the spring of 2020:

1. A 2020 Textron Scholarship Program Entry Form must be completed and submitted by **March 31, 2019**. The Entry Form for the 2020 competition is provided in Entry Step 3 (Complete Entry Form).
2. The student must take the PSAT/NMSQT in the fall of 2018, on the date his/her school chooses for the administration. At the beginning of the 2018 - 2019 school year, the student should obtain a copy of the *2018 PSAT/NMSQT Student Guide* from the high school counselor and make arrangements with the school to take the 2018 PSAT/NMSQT.

If more than one parent is an employee of Textron Inc., each parent should submit an Entry Form for the same child.

### **Important information about the October 2018 PSAT/NMSQT**

- The **October 2018 PSAT/NMSQT is the qualifying test to enter the 2020 competition**. Scores from prior PSAT/NMSQT administrations (2017 or earlier) cannot be used for participation in the 2020 program.
- The 2018 PSAT/NMSQT will be administered as follows:

**Primary test date: Wednesday, October 10, 2018**

**Saturday test date: Saturday, October 13, 2018**

**Other test date: Wednesday, October 24, 2018**

- The 2020 Textron Scholarship Program Entry Form can be submitted prior to the student taking the October 2018 PSAT/NMSQT and/or receiving his/her official score report.
- As a cosponsor of the examination, NMSC receives all October 2018 PSAT/NMSQT scores and information students provide on their answer sheets. Therefore, students do not need to report their PSAT/NMSQT scores to NMSC.

#### **Unable to take the October 2018 PSAT/NMSQT?**

If a student does not take the October PSAT/NMSQT because of **illness, an emergency, or other extenuating circumstances** (but meets all other participation requirements), he/she may still be able to enter the 2020 competition. To request information about possible arrangements for alternate testing, write directly to NMSC as soon as possible after the October 2018 PSAT/NMSQT administration, **but no later than April 1, 2019**. Do not delay, the earlier you write, the more options your child will have for scheduling test dates.

The alternate entry request should include the name and address of the student; the contact

information of the person making the request; the name and address of the student's high school; and a brief explanation of why the student missed the October 2018 PSAT/NMSQT. Requests for alternate testing instructions may be sent by:

### How are winners selected?

All Textron Scholarship winners in 2020 will be chosen from a group of candidates who (1) score high on the 2018 PSAT/NMSQT and (2) are notified by NMSC in the fall of 2019 that they may receive further consideration for a scholarship by meeting several academic and other requirements set by NMSC. Scores from the 2018 PSAT/NMSQT will be used by NMSC as an initial screen of applicants in the 2020 Textron Scholarship Program. **Entrants who advance in the competition will be contacted by NMSC on or before December 31, 2019.** (Only those entrants who advance in the competition will be notified and receive materials from NMSC.) These students and their high school principals will complete applications that include biographical and academic information that must be filed with NMSC. Scholarship winners will be chosen on a competitive basis and without regard to family financial circumstances, gender, race, ethnic origin, or religious preference. An NMSC committee of professionals trained in selection will choose the winners by evaluating several factors about each eligible candidate; these include academic record throughout high school, significant activities and contributions to the school and community, test scores, the school's recommendation of the candidate, and the student's essay about personal characteristics, activities, plans, and goals. In most cases, winners will be notified by NMSC in March of 2020. All winners are notified directly, prior to any public announcement that may be made about recipients.

### What is the amount of the award?

Each Textron Scholarship stipend is \$1,000 per year for up to four years of college undergraduate study or until baccalaureate degree requirements are completed, whichever occurs first. The winner's annual stipend will not be affected by other scholarship aid or by an approved change in college.

### Are there requirements that scholarship winners must meet?

Yes. The formal Textron Scholarship offer that NMSC sends to each winner specifies terms for acceptance of the award. A winner must be granted and accept admission to college no later than the fall following selection and must enroll as a full-time undergraduate in a college or university in the United States that holds accredited status with a regional accrediting commission on higher

education. (Scholarship stipends are not payable for attendance at service academies or certain institutions that are limited in their purposes or training.) Also, the winner must pursue a course of study leading to one of the traditional baccalaureate degrees, and remain in good academic and disciplinary standing.

### **Who handles scholarship procedures?**

All phases of the competition, including the selection of winners and payment of scholarship stipends are handled for Textron Charitable Trust by National Merit Scholarship Corporation.
