The 500 families live in 24 different villages, and each family receives workshops and home visits from Qachuu Aloom's field team, as well as access to other special educational workshops and help marketing their crop and seed surplus. Mothers and their children in our maternal health project receive monthly health assessments from a nutritionist, vitamin supplements, hygiene cooking and gardening classes. Serving 500 families.
