Two dozen adult church leaders from around the state participated in the 6th leadership training we've conducted, and we brought together 120 faith communities statewide to install solar arrays on their churches, host educational events, take part in marches, and meet with elected officials. In addition, we trained 24 youth in leadership skills through our overnight youth adventure camp experiences. 60 youth and 15 youth counselors attended our week-long All in the Circle Creative Arts and Natural camp. Together they connected with the natural world, built community around caring for the earth, and co-created of a culture of kindness. Together with partners, we organized more than 550 faith leaders to sign a public letter to our state governor in moral opposition to building an oil pipeline across Anishinaabe treaty lands in northern MN, affecting many important bodies of water. In September, we co-hosted an interfaith vigil at the sacred Mississippi Headwaters, which are threatened by this pipeline. 150 Muslims, Jews, Hindus, Buddhists, Christians and many others participated in a water ceremony led by Indigenous women. In other intercultural programming, we held our fourth Unity Iftar Block Party during the holy month of Ramadan, attracting over 400 people of different faiths to honor the leadership of Muslim women.

Through the Just Solar Coalition, we worked with six solar developers to create model projects across Minnesota, employing workforces of >50% people of color and allowing local community members to become cooperative owners of their own energy. MNIPL convenes the coalition, playing a central role in the group's work to advance equitable solar. In partnership with the MN Department of Corrections, the Mid-west Renewable Energy Association, and Solar Bear (the first indigenous-owned solar installation company in the state), we trained 13 incarcerated individuals in the skills necessary to install solar panels on homes and businesses, and found employment for them as they were released.
