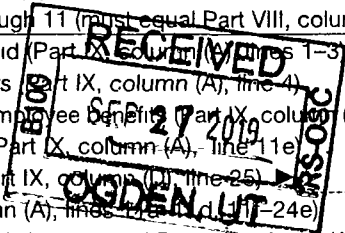

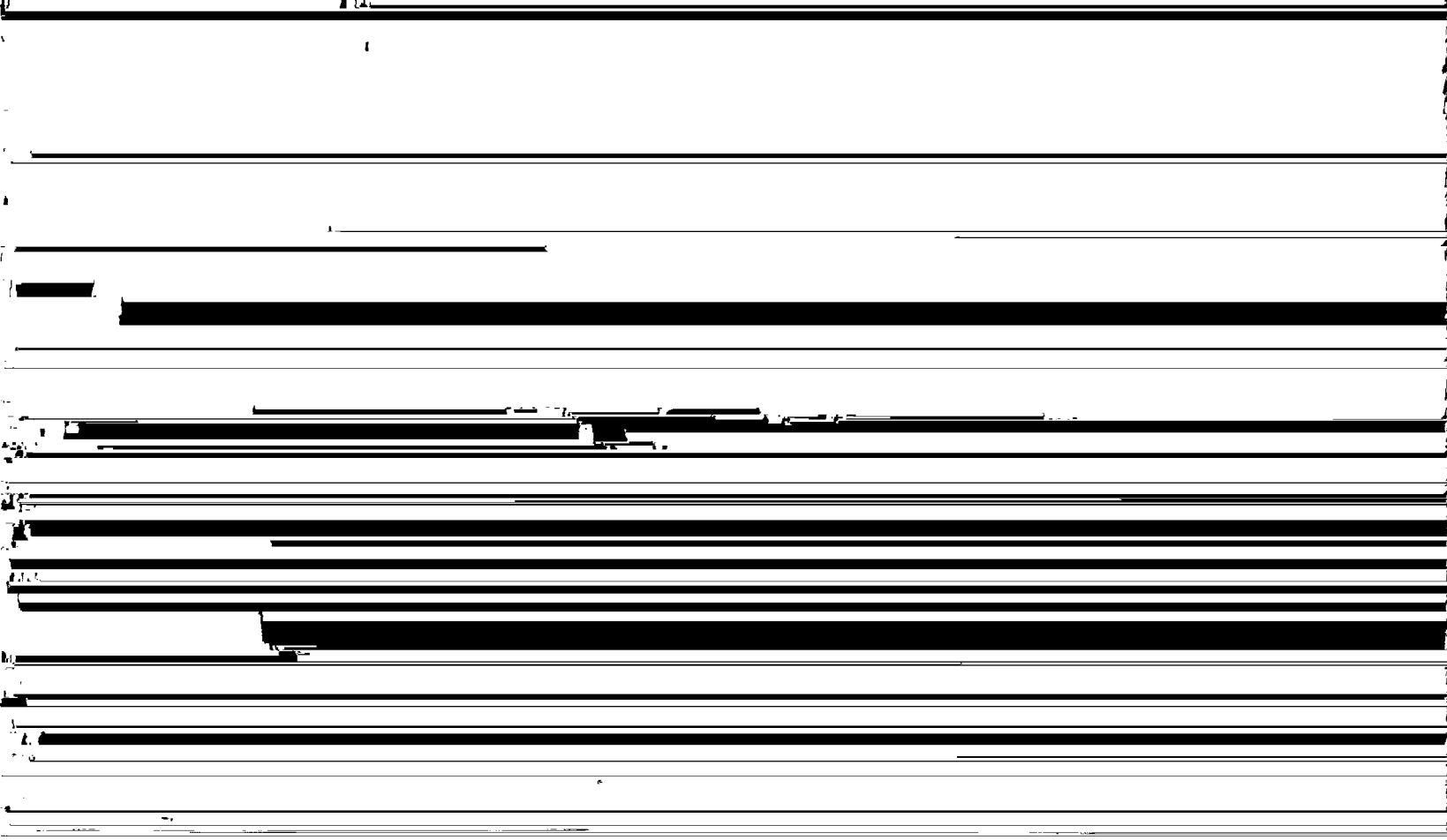

Held 2 sessions of a 4-day overnight summer camp experience for 87 youth with autism spectrum disorders and 33 youth peer models (120 total youth campers) and 2 sessions of a 2-day overnight spring/fall camp experience for 56 youth with autism spectrum disorders and 9 youth peer models (65 total youth campers). Campers were provided \$55,0550 in scholarships for camp. Unique aspects of the program include: direct social instructions; sensory supports; visual strategies; positive behavioral supports; involvement of graduate and doctoral students; peer models; ropes course and/or zipline; traditional camp activities, such as horseback riding, archery, fishing, swimming, hayrides, art activities, and singing around the campfire; and activities tailored to the individual campers' interests.
