James reviews all wild cat conservation proposals 3 times a year for MbZSCF. The MbZSCF small wild cat conservation budget was \$99,000 in 2017. In addition to the MbZSCF budget Small Wild Cat Conservation Foundation contributed \$20,367 to support more small cat conservation projects.
