James reviews all wild cat conservation proposals 3 times a year for MbZSCF. The MbZSCF small wild cat conservation budget was \$99,000 in 2017. In addition to the MbZSCF budget Small Wild Cat Conservation Foundation contributed \$20,367 to support more small cat conservation projects.

The Small Wild Cat Conservation Foundation Endowment Fund is intended to support small wild cat conservation efforts globally

using interest generated by the endowment fund when the fund's total value exceeds \$2M. The fund is invested in interest bearing

securities. Interest in excess of inflation can be used to support in situ conservation efforts. Interest equal to the inflation rate will be

reinvested to grow the endowment fund. In mid-2018 The Small Wild Cat Conservation Fund was transferred to Global Wildlife Conservation,
