FOR U supports ongoing physical therapy services provided by Dr. Brooke Riley, PT, DPT, Dr. Bethany Wolf, PT, DPT and other visiting therapists in rural Jamaica. Services provided at the clinic include rehabilitation for orthopedic, neurologic, and developmental diagnosis. In November, FOR U moved into a larger clinic space in Top Hill, St. Elizabeth. This will allow us to grow our services and reach more people in need. In 2018, the FOR U staff completed a total of 1,232 patient visits at the St. Vincent Strambi Health Center and at the new location. This program serves to further FOR U's exempt purposes by supporting charitable medical services to underserved populations. Our objective of improving the quality of life of the people we serve was met by improving their functional mobility and helping them to become more independent with their activities of daily living.

Stroke Camps:

In 2018, FOR U ran four stroke camps in March, May, September, and December. We continued using our new model which consisted of seven full days of intensive neurological rehabilitation as patients work to improve their gait, balance and arm/hand function. This change allowed the implementation of home visits and community outings with patients which helped to increase their function in the community. Pre/post testing was done in the first and last days of the camp to measure functional changes in these areas. Eighty-eight US/Jamaican volunteer physical therapists and physical therapy students from seven different universities participated in the camps. A total of thirty-two patients were served, all of which made dramatic gains in their functional mobility. This program serves to further FOR U's exempt purposes by supporting charitable medical services to underserved populations and providing opportunities for volunteers to be involved with improving the quality of life for those living in underserved areas. Our objective of improving the quality of life of the people we serve was met by improving their functional mobility and helping them to become more independent with their activities of daily living. Our long term

goal is to reduce the incidence of stroke in Jamaica through raising awareness and health education to the public. In the future, we also aim to provide more comprehensive rehabilitation services including speech and occupational therapy as well a nutrition education and counseling.

Home Visits:

FOR U also provides home visits for those patients who are unable to come to our clinic due to decreased mobility or lack of transportation. In 2018, FOR U completed sixty-six home visits throughout the parish of St. Elizabeth. This program allows us to better meet the needs of our patients by improving their functional mobility in the home and working on activities that are important to the patient. This program serves to further FOR U's exempt purposes by supporting charitable medical services to underserved populations. Our objective of improving the quality of life of the people we serve was met by improving their functional mobility and helping them to become more independent with their activities of daily living.

Mom's Support Group.

FOR U recognizes the financial and emotional strain on single mothers who have children with special needs. In order to help improve the quality of life for them and their children, FOR U created a Mom's Support Group. In 2018, the group met once every few months to provide educational, emotional, and financial support. Mom's were given small grants to assist with start-up costs of small businesses, such as raising and selling chickens. Eight mothers participated in the support group and 2 mothers were given financial assistance. This program serves to further FOR U's exempt purposes by supporting charitable services to underserved populations and improving the quality of life of the mothers and children that we serve.
