Service to the Poor & Mission Trips - By serving the poorest of the poor, Creatio aims to bring missionaries closer to seeing the face of Christ - thereby reconciling themselves to one another and to the Creator - as well as showing those who we serve that they are greatly loved. Throughout Creatio's history, we have completed over 35 successful mission trips across 7 different countries. Our projects include working alongside locals to provide housing, water, and community spaces; helping with relief efforts, such as the disastrous 2013 Philippines typhoon; providing spiritual and catechetical classes; and many others.

Environmental Stewardship - As Pope Francis explains in Laudato si', "Concern for the environment thus needs to be joined to a sincere love for our fellow human beings and an unwavering commitment to resolving the problems of society." Creatio believes that in reconciling human beings with nature, we will grow closer to solving the many cultural, spiritual and educational challenges around us. Creatio's environmental projects include restoration of the natural environment in the Galapagos Islands, educating local communities on environmental best practices and hosting several academic environmental conferences.

Outdoor Adventure - As Denver Archbishop Samuel Aquila wrote, Creatio "promotes activities in nature with young people as a way to help them encounter Jesus, who so often "withdrew himself into the wilderness and prayed" (Luke 5:16)". By bringing people into nature and allowing them to experience the beauty of creation, Creatio has been able to ignite a flame within the hearts of young people and open the door to deeper conversations of the role that Jesus plays in their lives. Creatio has completed over 10 outdoor adventure trips in its history, including walking the Camino de Santiago in Spain, skiing, hiking, rock climbing and making pilgrimages to the Santuario de Chimayo in New Mexico.
