Forward MT Foundation's (FMF) mission is to educate, engage, and organize youngMontanans to shape their democracy to improve their lives and the lives of fellowMontanans. To accomplish our mission we engage young people in voter registration, voter mobilization, leadership development and issue advocacy through peer-to-peer engagement. In 2018, staff and volunteers registered 5,212 people to vote across the state of Montana on college campuses, in high school classrooms and at community events. Nearly 85% of these voters were between the ages of 18 and 34. FMF hosted the largest National Voter Registration Day celebration in the state registering 332 voters across eight communities in a single day. FMF mobilized young voters to cast their ballots. Staff and volunteers made 13,089 get out the vote calls helping young Montanans how, where, and when to cast their votes. We also helped to mitigate barriers to voting for historically marginalized communities, coordinating and training partner organizations and volunteers to monitor elections in 14 Montana counties. In 2018 FMF graduated 36 interns from our Community Organizing Internship Program with field and classroom experience in grassroots tactics and strategies. We also piloted our first high school fellowship program with a class of 5 high schoolers who hosted events at their high schools, led their peers through our Underage Democracy civics templates in the government classes and participated in remote on-line classes about grassroots organization. We hosted the Annual Montana Youth Organizing Summit, which brought 73 young Montanans together for two days of hands on training about volunteer development, issue campaign planning, fund raising, earned media, and racial justice. At this event, FMF honored 25 young Montanans who are moving their communities forward through the 25 Under 25. We advocated for policies that reflect the experiences, values and vision of young Montanans. We hosted local educational happy hours, collected stories and testimonies from our peers, supported young people in writing and submitting letters to the editors and OpEds, and monitored legislation. This included advocacy efforts around LGBTQ equality, renewable energy, public lands, affordable higher education and housing, and voting rights.
