Amplify Program: Focused on changemakers in tuberculosis, child marriage and mental health. In mental health, we advanced key partnerships with collaborating organizations and developed our changemaker program. In tuberculosis, we achieved inclusion of community-based health service delivery and psychosocial & socioeconomic support in the first-ever United Nations (UN) Political Declaration on Tuberculosis; achieved priority for increased investment for community-based health systems in the Civil 20 high-level policy report to the Group of Twenty (G20); achieved priority status for action on patient financial hardship in the UN General Assembly Civil Society Hearing report advising the UN High-Level Political Forum on TB agenda, and achieved inclusion of community health worker programs as a solution to antimicrobial resistance (AMR) in primary, high-level report to the UN Secretary-General. In child marriage, elevated child marriage as a priority agenda item with key policy and program budget decision-makers focused on refugee populations, girls' education and girls' health at global and national levels. We expanded the reach of our child marriage curriculum through Discovery Education's platform to 30 million students, and worked with young people from around the world on their community-based advocacy to end child marriage.

Strongheart Bridge Scholars Program: The Strongheart Bridge Scholars Program provides a platform of financial, logistical, and advisory support for exceptional students of any age from challenging life circumstances to allow them to access academic scholarships that enable them to reach their full potential. The program provides essential funding that bridges the gap between academic scholarships and the other additional necessary expenses that are required to enable students to use their scholarships.
