International Program - Delegation & Volunteer Opportunities: Movement of Youth partners with community organizations to send high school & college students of color to engage in international work & volunteerism abroad during the summer. These international experiences are designed to empower these students to be more effective, respectful of other cultures political and economic systems, and willing to take a stand for the world's welfare. In 2018 Movement of Youth was able to sponsored 16 participants on a WFP (Witness for Peace) delegation to Cuba which explored the race, politics and culture of Cuba through dynamic participatory people-to-people educational experiences & discussion. MOY also sent 2 student to St. Vincent & the Grenadines to help to facilitate the ADARE Soccer camp while learning about the local culture and customs of the islands.

MBK College Tour: Visiting campus is one of the most important steps a student can take in deciding if a particular college is right for them. However, traveling to these campuses can be extremely expensive. As such, Movement of Youth, in collaboration with other community organizations, hosts MBK College Tour annually where students visit colleges and universities across the country to get to know the students and faculty who bring these institutions to life. The 2018 MBK College Tour featured tours of the following schools: Fayetteville State University, Morgan State University, University of Pennsylvania, Temple University, State University of New York, & Columbia.
