FAMILIES RECEIVING SNAP WHO PURCHASED PRODUCE AT PARTICIPATING SITES RECEIVED A VOUCHER FOR UP TO \$20 TOWARD THE PURCHASE OF COLORADO-GROWN FRUITS AND VEGETABLES. IN 2018, THE PROGRAM REACHED 4,401 TOTAL CUSTOMERS, WITH 43% HAVING AT LEAST ONE CHILD UNDER THE AGE OF 18. IN ORDER TO REACH COLORADANS WHO PARTICIPATE IN SNAP, THE OUTREACH TARGETED LOW-INCOME AUDIENCES AND WERE PRESENTED IN BOTH ENGLISH AND SPANISH. LIVEWELL ALSO IMPLEMENTED A COMMUNITY FOOD ADVOCATE PROGRAM IN 2018, WHICH COMPLEMENTS THE EXISTING DOUBLE UP PROGRAM. THE ADVOCATE PROGRAM HAS A GOAL OF TRANSFORMING DOUBLE UP INTO A MORE GRASSROOTS AND SUSTAINABLE INCENTIVE PROGRAM BY WORKING WITH SNAP PARTICIPANTS AS KEY AMBASSADORS AND DECISION-MAKERS IN PROGRAM OUTREACH AND PLANNING, AND INCREASING LIFE-LONG FRUIT AND VEGETABLE CONSUMPTION BY SNAP PARTICIPANTS. LIVEWELL'S SCHOOL FOOD INITIATIVE (SFI) INVESTED OVER \$474,771 IN PROGRAMS TO TRANSITION SCHOOL DISTRICT KITCHEN OPERATIONS TO OFFER FRESHLY PREPARED STUDENT MEALS. SFI CONDUCTED SCHOOL MEAL ASSESSMENTS WITH RECOMMENDATIONS FOR SCHOOL DISTRICTS, PRESENTED CULINARY WORKSHOPS TO TEACH FUNDAMENTALS OF SCRATCH COOKING, AND DEDICATED A TEAM OF ON-SITE CHEF CONSULTANTS TO PARTNER WITH DISTRICTS THROUGHOUT THE SCHOOL YEAR IN CREATING AND IMPLEMENTING SUSTAINABLE CULINARY ACTION PLANS TO IMPROVE STUDENT MEALS. IN 2018, A MAJORITY OF SFI PROGRAMMING SUPPORTED DENVER PUBLIC SCHOOLS, ONE OF THE FASTEST GROWING SCHOOL DISTRICTS IN THE UNITED STATES. LIVEWELL HOSTED A SIXTH ANNUAL HEAL SUMMIT, WHICH CONVENED MUNICIPAL AND COMMUNITY LEADERS TO LEARN AND SHARE BEST POLICY AND ENVIRONMENTAL PRACTICES TO REMOVE BARRIERS TO HEALTH THROUGHOUT THE STATE.
