Part III - Malawi Matters Inc is a 501(c)(3) not-for-profit organization with a United States based all volunteer board of directors and staff whose mission is to develop and facilitate HIV/AIDS education with the people of Malawi and Central Africa and to educate Malawian and Central African women for life improvement. Malawi Matters Inc uses proven techniques utilizing local arts and learning methods grounded in Malawian culture to find solutions to the HIV/AIDS crisis and improving the communities impacted by supporting the life improvement of local women and female youth. In 2018 Malawi Matters Inc has continue to expand the delivery of the these educational methods in this economically impoverished, but spiritually rich nation by assisting in the formation of Non-Governmental Organization (NGO) in Malawi and by assisting the Malawian led NGO to work with the agencies, organizations and communities to further the HIV/AIDS education in that country. Malawi Matter Inc continued expansion of the HIV/AIDS program and women services by equipping additional area and regional representatives to reach new areas, disctricts and communities.

Part III, Line 28 - Malawi Matters Inc was incorporated in May 2008 and formed a Board of Directors in September of 2008. The Internal Revenue Service granted Malawi Matter Inc IRC section 501(c)(3) status in December 2008.
