Our mission is planting fruit trees to feed people, create jobs and benefit the environment. We work in developing countries including Jamaica, Haiti, and other Caribbean and African countries. We also supply processing equipment, we support schools by distributing locally produced food and educational material, and we provide agronomy training.

FRUIT TREES: Working in cooperation with the Rural Agricultural Development Agency and other partner organizations in Jamaica, and Three Angels Childrens' Relief and other NGOs in Haiti, we distributed approximately 25,695 fruit trees. Fruit tree planting is the core of our operations and mission. Our other programs exist to support this program.

4b (Code:) (Expenses \$ 32,597 including grants of \$) (Revenue \$)

FOOD: we purchased and distributed over 10,563 pounds and over 4,200 pounds of instant porridge mix produced locally in Jamaica and Haiti. We donated the equivalent of approximately 150,000 meals to schools and orphanages to 50 institutions for young children.

EQUIPMENT: we supplied a commercial food processor and a grinding mill to a processor in Jamaica, and we supplied a hybrid solar dryer to another processor in Jamaica. The equipment allows fresh fruit to be dried and ground into flour with a long shelf life. The flour is suitable for many products including a dry instant porridge mix. We help entrepreneurs to start up operations then we see to their successful independent launch after 2 to 3 years.
