Line 10: Grants were given to other non-profit, Christian organizations within the US totalling \$4,950. The Navigators received \$1,100 and Trinity Church of Hereford (our spiritual covering) received \$900. Miscellaneous donations to other organizations totalled \$1,500.

Line 16. Other expenses which dominate our total were \$115,589. These are unique to our organization as we support travel to Africa, and our program expenses are mostly realized in Africa.

1. Mission trip expense was the largest portion of this total, \$90,165 plus actual air travel of \$7,207. These expenses cover everything from bringing other supportive personnel in from local areas, to doing recon work by these, purchasing medicine, renting 4x4 vehicles, food, housing, communications, fuel, for all of the many missions conducted last year, not just the two that I personally conduct. There were 288 villages that were visited last year where the gospel was preached. LBNF sponsored them all. Estimated medicine costs were \$8,000.

2. Equipment and evangelism supplies (microphones, megaphones, speakers, DVD players, projectors, Bibles, Proclaimers, etc.) accounted for \$4,429.

3. Humanitarian Aid was \$3,209 including carry over support for the flood victims on Mt. Bagazam, Niger, as well as a microeconomic gift of a tricycle to one of our evangelists in Burkina Faso. He has provided financial reports monthly describing his business success centered around transportation of people within the village and also items for purchase (food, etc.).

Line 20

The three dollars listed here represents deviations in rounding figures used in calculating line items and is of no real significance.

Part III

You will note that the "foreign grants" box has been checked on this return. That decision was based on the fact that Africans are the beneficiaries of most of our program expenses although direct gifting to individuals is a small percentage of our overall expenditures. The benefits include, receiving medicine, food, assistance with evangelistic activities, and equipment for conducting evangelistic activities.

Lines, 28,29 and 30 have this box checked and the estimated gifting in parentheses. Formal grants, per se, have not been instituted.
