Our Grant per Diem program has been renewed for Veteran women with dependent child. We have exceeded our expectations and measures in that ninety (90%) of our participants have obtain jobs with some of the local merchants (Wal-Mart, Maverick Stadium, Amazon and Snapples) and have acquired permanent housing. Ninety-five percent of our women consumers who are in our non-veterans program have obtain their children back from Child Protected Services since they now have stable housing with LCD and are moving forward to permanent housing. One hundred percent of our veterans have been re-housed with our partners US Vets and Lighthouse Social Services and KEYS.
