IN 2018, THIS WORK INCLUDED - SCORE DEVELOPED THE 2018-19 STATE OF EDUCATION IN TENNESSEE REPORT TO REVIEW WHAT WAS ACCOMPLISHED FOR STUDENT ACHIEVEMENT IN THE PAST YEAR AND IDENTIFY WHAT NEEDS TO HAPPEN IN THE YEAR AHEAD TO ACCELERATE THE STATE'S EDUCATION SUCCESS. 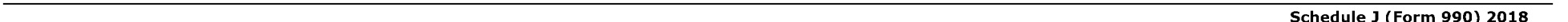
