Scientific research of tropical rainforests, native wildlife, and sustainable food production. Approximately 40 national and international volunteer researchers and interns conduct research out of the Reserve's research station, which operates year-round. This program includes visiting groups of Biology students from international universities that come to the Reserve to research and learn about Tropical Ecology and conservation.

4b (Code:) (Expenses \$ 58,252 including grants of \$ 19,320) (Revenue \$)

Management of the Jama-Coaque Ecological Reserve which protects 1,400 acres of tropical rainforest in coastal Ecuador. The Reserve preserves the forests and watershed of the Camarones River, which benefits three neighboring communities with a total population of approximately 2,000 people.

In addition, two of the organizations Program Directors and the three Co-Founders visit TMA's administrative office in Quito and TMA's ecological project (the Jama-Coaque Ecological Reserve) on a rotational basis. All six of these individuals provide monitoring and auditing of TMA's funds internationally. TMA also has a signed agreement and receives quarterly financial reports and updates from the board of directors of the Ecuadorian organization Grupo Ecologico Jama-Coaque (GEJC) that received grants from TMA during 2018.

Part I Q3-1 (d) & Q3-1 (e) 100% of TMA's funding and expenditures are to carry out the mission of the Reserve. A more complete description of TMA's mission and program services are described in TMA's Form 990 Part III and in Schedule "O".

Part II Q1(d) To have "local" (i.e., Ecuadorian) people assist international researchers and interns to carry out the mission of the Reserve. Key aspects of TMA's/ the Reserve's mission and program services are to restore and maintain the Reserve's 1,400 acres of rainforest in Manabi Province, Ecuador, conduct rainforest research, protection of wildlife, including rare species, sustainable development, agroforestry, and provide local community outreach to three towns adjacent to the Reserve.

Part II Q1 (e) In 2018 TMA made \$84,000 grants to an Ecuadorian organization "Grupo Ecologico Jama Coaque" ("GEJC") for full-time, on-the-ground services and assistance in carrying out the mission and program services of the Reserve. Services provided by GEJC personnel include assistance to international researchers and interns, menial labor for Reserve maintenance, housing, food services. TMA has a signed agreement with the board of directors of GEJC and receives quarterly financial reports for grants received. In addition to TMA's grants to GEJC for assistance in managing/maintaining the Reserve TMA had \$76,397 of direct expenditures to carry out the Reserve's mission.

Part II Q1 (i) Ecuador uses the US dollar as its currency. All grant funding to GEJC from TMA was in US dollars paid via wire transfers from TMA's checking account with Bank of America in the US to GEJC's account at Banco Pinchincha, Ecuador's largest bank.

Camarones River, which runs through the Reserve, and also serves three adjacent indigenous Ecuadorian communities with a
combined population of 2,000 people. TMA/the Reserve also serves as a platform for research on coastal rainforests, sustainable
development, agroforestry, and rainforest conservation. Approximately 40 unpaid volunteer international researchers, students, and interns
visit the Reserve at one time or another throughout the year to carry out TMA's/the Reserve's mission. Due to the Reserve's remote
location researchers and interns require on-site living accommodations. "Grupo Ecologico Jama-Coaque" ("GEJC"), an Ecuadorian
social services and support organization assists TMA/the Reserve in carrying out its mission, which also includes some
community outreach to local indigenous communities, notably the adjacent village of Camarones.
