During 2018, Blossom Hill Foundation provided grants to 11 organizations for programs benefiting children, which were implemented by 12 fellows in several countries around the Middle East, southeast Europe and Southwest Asia. During 2018, Blossom Hill Foundation provided operating grants to one organization: o Sisters 4 Sisters. This is a hands-on personal development program for at-risk Afghan girls and women. Sisters 4 Sisters uses four program areas to foster personal growth: work and problem solving, physical wellbeing, psychosocial development, and mentoring. The program enrolled 40 girls, ages 14-15, who came from Kabul Scouts program, assisted housing programs, and/or who have lost parents or have parents in jail. The program meets three times a week for ninety minutes to two hours. \$ 7,500. During 2018, Blossom Hill Foundation sponsored eleven programs implemented by 12 fellows: o Project Lift - Hold My Hand. This program supports the increasing need of psychosocial services for refugee children living in Turkey. Her program uses art, music and dance modalities as a form of therapy to support refugee children and creates a safe environment for them to heal from the trauma of war. By the end of spring 2018 session a total of 150 refugee children, ages 5-17, attended her group sessions. Each child participated in 6-8 weekend sessions, divided by age and group dynamics. Each group had 8-12 children who participated in various music, art and dance modalities. This program was renewed in winter 2018. Over 200 children are benefiting from one or more sessions provided including one-on-one homework support, creative art therapy methods used to discuss important topics that ensure childrens short-term and long-term safety and well-being, and a drop in time for positive and creative activities where children spend 15 minutes per day in the center to draw, read books or play some creative games. o Youth Empowerment Program. This program is designed to prepare refugee high school students for higher education in the United States. This program provides TOEFL and SAT preparation classes, as well as one-on-one mentoring, to guide students through the college application process. By the end of the Spring 2018 session, the program accepted 36 applicants (75 percent male, 25 percent female). Students are mostly from disadvantaged backgrounds with some knowledge of English. Students sat on SAT exams and TOEFL. College applications were submitted on December 31 (about 10-12 colleges a student). This program was renewed in winter 2018. The program accepted 40 students (20 girls, 20 boys) and 10 ad-hoc students who are not part of the formal class. This is a 160 percent increase from the second cohort last year. Program now has 28 mentors based in the US. Program expanded to UK, Canada and international colleges. o Code to Inspire. This is the first coding school for girls in Afghanistan. The program offers young Afghan women rigorous training in computer science with a curriculum focused on web development, mobile application development, gaming, graphics, and design. Eighty girls were enrolled and started a more advanced curriculum. Students completed 22 standard sticker sets with the theme Unity and Peace inspired by nine tribes in Afghanistan to deliver the message of togetherness. These stickers are available in WhatsApp messaging. A few Graphic Design students were hired to work on a project with a US-based company. Students will present their apps and games to potential users and companies in an exhibition to be held in March 2019. o Entrepreneurship and English-language Instruction. This program conducts classes in business entrepreneurship and English-language teaching methodology for young Afghan boys and girls, ultimately aiding them in starting their own careers. There are 35 boys and 40 girls enrolled. Classes are taught every other day. o Team Up 2 Teach. The program uses a co-creation model that brings together teachers from various refugee communities in Europe, volunteers, development professionals and experts in trauma to identify teaching and learning gaps and address them by developing a living digital guide available to all instructors on the field. The goal is to provide more effective teaching and to create a safe and supportive learning environment for the students so they can learn. o Science Kits. This program provides science experiments with practical outcomes knowledge and take-home science kits. The program delivered 3080 kits to refugee camps in Greece and conducted workshops with educators. The kits included videos, translated science vocabulary documents in four languages and activity plans. o Azraq School. This is an Early Childhood Center to support early academic and behavioral needs of young refugee and other vulnerable children through alternative education activities inspired by Montessori methods. The Blossom Hill Early Education Center will open at the end of January 2019 and will be the only one of its kind in Azraq. The center provided 180-hours of Montessori teacher training to 11 trainees who will be allowed to sit for an exam and obtain a certificate from the Ministry of Education. It will enroll 30 students in the first cycle. o STEM2Blossom - Blossom Hill STEM Center. This is a STEM Center that provides the youngest refugees an opportunity to learn science and train unaccompanied minors as apprentices to inspire them to continue to pursue their education and possibly become teachers themselves. In 2018, 30 children, ages of 5-9, and 5 unaccompanied minors, ages 14-17, participated in the program in the first semester of the trimester program. The curriculum theme is One World/One City where children try to resolve contemporary problems of society by building a new city with the 17 UN Sustainable Development Goals as a guide. To date, the program enrolled 5 unaccompanied minors and 30 children. They had an exhibition of childrens work to local stakeholders (NGOs, government municipalities). o El Sistema - Blossom Hill Beginners Orchestra. This is a beginners orchestra that promotes the social inclusion of refugee children in Greek society. 82 students have enrolled, 70 percent are refugees and 30 percent Greeks. The instruments have been bought or donated for the new orchestra, teachers have been hired including a conductor who shares the values of El Sistema, outreach officer (a refugee himself) has reached children in the refugee communities to encourage them to join the program, a specific and dedicated repertoire for this new orchestra has been created. The orchestra already performed its first concert in December 2018. o Sports for All. This program brings refugee children and youth from all parts of the world together with Jordanians to play soccer and basketball. Through their love of sports, this program is working to unify them on a common ground. The program chose a basketball trainer, an Iraqi refugee with a lot of experience. A total of 14 boys and girls are participating in a ten-hour leadership training. They will lead teams and do exercise with kids. The program has registered up to 20 kids for basketball on first come first serve basis. o Article 26 Backpack. This is a humanitarian tool that empowers refugee and other at-risk youth to better connect to higher education and employment opportunities. It provides them with a way to safely store and share academic credentials, create narratives of achievement, and envision a future through higher education. The Backpack platform was launched in Arabic. It was distributed to 600 students in Lebanon. Many have begun to request credential evaluation and certification. The Backpack has two parts: educational pouch (high school diploma, letters or recommendations) and portfolio pouch (vocational training). An additional section allows students to upload a video statement. The project is working to develop sustainability models and a way to build-out the existing consortium that can bring together corporate, non-profit, university, and refugee communities to administer and advocate for the Backpack. Total \$301,250.
