ANY INDIVIDUAL OR ORGANIZATION CAN APPLY TO THE FOUNDATION FOR ASSISTANCE, OR SOMEONE CAN APPLY TO THE FOUNDATION ON ANOTHER'S BEHALF. THESE FUNDS ARE GENERALLY EMERGENCY FUNDS, PRIMARILY FOR MEDICAL PURPOSES, AND OTHER COMMUNITY NEEDS. SOME SMALL SCHOLARSHIPS ARE GIVEN. A "DANCE HALL" WAS DONATED TO THE FOUNDATION IN 2014, WHICH IS RENTED AT MINIMAL OR NO FEE FOR COMMUNITY EVENTS. DONORS ARE PRIMARILY LOCAL INDIVIDUALS, AND SOME DINNERS AND AUCTIONS ARE HELD FOR FUNDRAISING. SOME SOLICITATION IS DONE BY MAIL. AN UNUSUAL GRANT WAS RECEIVED IN 2015.
