StreetLightUSA's mission is to transition girls from trauma to triumph! We serve girls ages 11 to 17 who are victims of, or at risk for, child sex trafficking. There is no one-size-fits-all solution to caring for a traumatized child, so StreetlightUSA offers research-based programs & services, implemented by trauma-informed staff, and uniquely tailored for each girl. Individualized plans initially address their basic crisis intervention and safety needs and ultimately guide them to productive independence & success. [See Schedule O]

Transitioning Girls from Trauma to Triumph: In 2018 StreetLightUSA served 61 girls, with an average length of stay of 48 days in this program. Significant aspects include individual and group counseling services, enrollment in school or a GED program, and being partnered with a mentor to assist in their development. In this program, each child's medical and dental needs are provided for with visits to a doctor during our weekly "Blue Bus" visits through our partnership with Phoenix Children's Hospital. They also learn valuable life skills, and experience a sense of family, living in a home setting with other children and staff. They have individual responsibilities including preparation and sharing of meals and daily chores. Group counseling sessions and survivor-led workshops are available to them and a key to their progress through the program. Each child acclimates at their own pace, and participation and engagement are expected and rewarded. A combination of "regular" activities, and a wide variety interesting and nurturing activities are integrated in this program to support their transition from trauma to triumph.
