The SOAR program aims to help our young people graduate from high school, attend college and succeed in life.

We held three three one week residential pre-collegiate academies (Prepare To SOAR, Learn To SOAR, Time To SOAR) on the UC Berkeley campus and served 43 foster youths, including junior counselors.
