WE CAN DO MORE WITH THE SCIENCE WE ALREADY HAVE AND BRING LIFE-SAVING TREATMENTS TO MILLIONS OF PEOPLE SUFFERING FROM RARE DISEASES. CURRENTLY, THERE ARE FEWER THAN 400 APPROVED TREATMENTS FOR 7000 RARE DISEASES AFFECTING MORE THAN 30 MILLION AMERICANS.
