Issue Advocacy and Education - In 2018, The SBA List Education Fund launched advocacy and educational efforts on a number of different issues related to the pro-life movement. These efforts included direct lobbying and grassroots lobbying where applicable.

Form 990, Part III, Line 4b:

Media & Communications - CLI increased its strong presence in national and specialized media in 2018. CLI publications were covered and/or CLI data and spokespeople were quoted or cited by ABC News, CNN International, The Washington Post, The Atlantic, Kaiser Health News, NPR, Science Magazine, Politico, EWTN, and many more. Opinion pieces written by CLI staff and associates appeared in Illinois Review, TribTalk (Texas), Washington Examiner, Western Journal, The Daily Caller, Townhall, The Daily Signal, The Federalist, First Things, Public Discourse, National Review Online, and more. Overall, CLI edited and placed 52 op eds by associate scholars in national media outlets. In addition to its other program emphases, CLI supports individual ad-hoc writing and research projects on various topics in bioethics and sanctity of human life issues. These projects include policy papers, fact sheets, and commentaries for publication on CLI's web site or in the general media (print or electronic), blogs, and other formats. Writers are drawn from the CLI's list of more than 60 expert advisors. CLI also maintained active lists of interested members of the public, including donors, policy allies, and interested citizens. CLI communicates with each of these constituencies through its participation in a quarterly newsletter co-published with SBA List, print copies of its major reports, commentaries, fact sheets, social media, and email alerts announcing the release of new material. Most lists currently number in the hundreds of addresses and nearly all of these are domestic U.S. contacts. Subscriptions and all other print publications are free.

Data Analytics - In 2018 CLI's Data Analytics Department continued to produce independent analysis of issues in public health and maternal-fetal medicine. The Department published a peer-reviewed article in the Open Journal of Preventive Medicine on supply-induced demand for abortion and a commentary in Obstetrics and Gynecology. The department finalized steps for a series of studies on the impact of abortion on Medicaid patients' utilization of other publicly funded services. In 2018, we added seven associate scholars, one of whom has extensive experience with data collection and analysis.

Ending Late-Term Abortion - In 2018, CLI continued to develop policy papers and commentary on late-term abortion in the United States. The papers examined the data made available by individual states regarding late-term abortion in their jurisdictions, as well as offered an overview of efforts to protect children with Down syndrome from late-term abortion. CLI also supported expert testimony on the reality of pain in the unborn at this stage of pregnancy and earlier, as well as other types of normative evidence supporting the separate humanity of the child in the womb (e.g., fetal surgery).

Legal Defense Fund - The SBA List Education Fund continued to support the Free Speech project launched in 2010. This project promotes freedom of speech on pro-life issues. Beginning in 2011, SBA Education Fund made grants to charitable organizations to fund legal action against cases that unconstitutionally restrict the freedom of speech of pro-life groups and other organizations in the public square.

Pregnancy Center/Abortion Data Collection - CLI continued its comprehensive national project to promote improvements in the nation's public system for reporting the incidence of abortion and pertinent characteristics. To accomplish this goal, CLI published 29 individual state reports and an overview of the most recent state-level data available. We continue to advocate for improvements in federal reporting by the U.S. Centers for Disease Control and to advise policymakers on information priorities. CLI maintained its contacts with U.S. pregnancy centers, advising on best practices and collecting data. CLI published the third in a series of landmark compilations of pregnancy center accomplishments in service to women and children. The report is called *A Half Century of Hope: A Legacy of Life and Love* (Pregnancy Center Service Report, Third Edition). CLI continued to expose unethical and ineffective fetal tissue research and advocate for ethical research alternatives. Associate Scholars as well as Director of Research David Prentice, Ph.D., provided expert testimony to the media and policymakers, including a House Committee, on scientific issues regarding fetal tissue research.

Stem Cell Website - CLI continued to promote its long-standing educational initiative on the benefits to patients of ethical, successful adult stem cells, stem cells derived without harming or destroying any human being. Adult stem cells remain the only stem cell showing validated success for patients, improving health and saving lives. The fact that adult stem cells are the true gold standard of stem cells for patients was highlighted in a peer-reviewed paper we published in *Circulation Research*, a top-tier medical journal. CLI has also educated on the effectiveness and ethical superiority of adult stem cells in fact sheets and media interviews, pointing out the scientifically published success of adult stem cells as part of Congressional testimony, briefings, public talks, and op-eds. In each effort, the centerpiece has been our website, stemcellresearchfacts.org, which in 2018 featured powerful videos of patients treated for multiple sclerosis and spinal cord injury, as well as additional efforts to educate the public on the story of a patient successfully treated for stroke.

Coalition Building - As a research and education organization, CLI seeks to complement work being done by existing organizations, to create collaborative relationships and projects wherever possible, and to disseminate its findings and recommendations to a broad national, local, and international community. In 2018, CLI participated in many collaborations with various organizations, including the Center for Bioethics and Human Dignity, the Midwest Stem Cell Therapy Center, the Christian Medical and Dental Association, the John Paul II Institute, and The Catholic University of America. CLI staff members delivered papers and presentations across the country, in Washington, DC, Kansas City, Cleveland, Ohio, Galveston, Texas, Oklahoma City, OK, St. Joseph, MO, and elsewhere.

Conscience/Health Care Alternatives - CLI continued in 2018 to make available information analyzing the impact of federal and state insurance exchanges on subsidies for plans that cover elective abortion. In addition to identifying policy remedies, such as enforcing the Affordable Care Act requirement of separate premium payments for abortion coverage, CLI worked with Family Research Council and co-researched and promoted [ObamacareAbortion.com](#), a resource to inform the public which, if any, premium-subsidized plans in their state include this objectionable coverage before they decide to buy.
