We held 16 Know Your Rights Seminars, 9 Last Will workshops, 3 Self Defense seminars and college lectures. Combined these
reached over 2000 people.

Protect Georgia Muslims by investigating anti-Muslim bigotry, building coalitions with other civil rights groups, and

to harassment, physical violence, workplace discrimination, public accommodation, government agency discrimination, etc.
