We integrated new content into our resources for public health practitioners to improve their systems, policies, and practices to better align with health equity goals and released a paper on further incorporating equity into the Public Health Accreditation process. We launched a pilot program to build the capacity of local health departments and community organizing groups to form deep partnerships in support of social justice campaigns. Finally, we trained public health agency staff to increase their understanding of and ability to take action on criminal justice issues and change the dominant narratives about criminal justice issues.
