We fulfilled our mission of helping abandoned and neglected cats by rescuing 209 cats from the streets and from high-kill shelters and finding homes for 203 cats in 2018. 18% of all cats rehomed were older or had special needs. We distributed two newsletters in 2018 aimed at promoting responsible pet guardianship and preventing euthanasia of adoptable cats. We worked cooperatively with many rescue groups and shelters in California to save cats and continued to provide a courtesy post service which allows members of the public who need to rehome their cats to advertise their cats on our website and utilize the services of our Adoption Counselors.
