By the end of 2018 we have already distributed 1,133,251 New Testaments and Book of Matthews in this region free of charge. OTHER PROGRAM SERVICES 8: JESUS FILM: As part of our initiative in the Sambalpur Koshal region, we with the help of locals had dubbed the Jesus Film in Sambalpuri language. During 2018 we had a total of 1984 screenings across villages covering a total viewership of 521,252. Gospel of Matthews and the New Testament were distributed free of charge during each screening of Jesus Film as well. Our team is in the process of dubbing few other movies to be screened in public places.
