PART II, Line 1(b):

The supported organization, The Montana Land Reliance (MLR), is a 501(c)(3) organization whose mission is to partner with landowners to provide permanent protection for private lands that are significant for agricultural production, forest resources, fish and wildlife habitat, and open space. The Foundation supports the organization by providing services and holding title to assets used to support the programs of MLR.

PART V, Line 1-b:

The Foundation granted \$423,471 to MLR to cover costs related to: 1) stewardship/monitoring of the conservation easement MLR held and monitored in 2018 (\$230,541); and 2) outreach activities to educate landowners, public officials, the general public (publications, travel, printing) (\$192,930).

PART V, Line 1-c:

The Foundation received grants totaling \$1,686,330 over the course of 2018 from MLR. These monies were invested to generate income for MLR's operations and education and outreach activities. The monies were invested as follows: \$377,500 to the Land Protection Fund (stewardship, monitoring, and enforcement activities); \$100,250 to the Education and Outreach Fund (operations and education and outreach activities); \$189 invested into the Conservation Fund (permanent endowment); and \$1,208,391 invested into the MLR General Operating Fund (operations).

PART V, Line 1-m:

MLR, per the Intercorporate Services Agreement executed by the two related entities, performs accounting and administrative services for the Montana Land Reliance Foundation. The Foundation paid MLR \$36,000 for the performance of these activities in 2018.

PART V, Line 1-p:

The Foundation reimbursed MLR for its portion of expenses related to the director/officer liability insurance (\$1,214), for costs related to the filing of the Foundation's annual corporate report with the State of Montana (\$25); and for costs of lodging at the annual meeting (\$251). The total reimbursement in 2018 was \$1,490.
