The program inspired Science, Technology, Engineering, Arts, and Math learning in children & youth through hands-on exploration and reflection. Children & youth participate in the 10 week program to gain a deeper understand of STEAM content, and developed an interest in STEAM related fields. Through weekly educational field trips, children learn innovators, scientist, artist, technologist, & engineers are contributors to the well-being of the community.
