



We provide free and low cost veterinary services to low income pet owners from two mobile veterinary hospital trucks. In 2018 we made preliminary expenses to open our animal hospital and adoption center. In 2017 we treated 6,549 pets of low income pet owners. We also provided free veterinary services for approximately 400 animals, at a cost of \$60.358, which was 5.66% of our total income, and 14.38% of our net income. We paid off the remaining \$500,000 of our mortgage on our new building, using some CDs which came due and some from profits from the year.
