Student Sponsorship Program The goal of the student sponsorship program is to provide school fees for Kenyan children to be able to attend secondary and post-secondary school through connection with sponsors in developed nations. This program is the backbone of Kenya Keys. In 2018, there were 289 actively sponsored students. Of these, 159 were secondary school students and 130 were college and university students. Proudly, 43 students graduated from secondary school, and 26 students graduated from college or university in 2018. This program was strengthened by 8 conferences for supporting our secondary and college students and their parents. The highlight of these accomplishments is the active participation of our graduated alumni returning to mentor and support the younger students. Upon graduating from secondary school, all graduates participate in an internship program whereby they volunteer for 6-9 months in various community institutions, i.e. schools, the chiefs office, libraries and health dispensaries. We currently have 273 actively engaged sponsors including individuals, families, book clubs, service clubs, schools and other groups in the United States and abroad. The exchange of letters between students and their sponsors is a hallmark of the program and serves to develop the ongoing relationships between the two. Over 537 individual letters were exchanged between students and their sponsors this year.

Infrastructure The goal of the Infrastructure Program is to further the effective impact of our educational activities through the provision of facilities and facility enhancements. In 2018 we completed the building of a girls dormitory at Taru Girls Secondary School to relieve the existing overcrowded dorm. Unfortunately, a devastating fire burned down the original dorm. Kenya Keys was able to mobilize its supporters to fund the necessary renovations to the burned dorm as well as complete the new one. Additionally, we funded the building of a secure safety fence to encompass the entire 16-acre campus so all students would have a safe and healthy environment in which to flourish as they focus on their education.

Education Support Programs Kenya Keys has established multiple programs in Kenya to support the effective education and development of students beyond the basic sponsorship component. These include the development of libraries and distribution of books through our Library Program, providing extra support for at-risk girls through our Girl Empowerment Program, supporting special needs students through our Ndohivyo Program and providing important skills through our Leadership Program. These efforts are all made possible by the dedication of our Partner Kenya Keys Kenya staff who serve out of our office in the village of Taru. This staff of 3 full-time employees also supports a girls club, the Save our Sisters (SOS), a boys club, the Save Our Brothers (SOB) and an alumni group. In 2018 we instituted a Laptop program to assure that our college students are well-equipped for their academic demands. The Kenya Keys Kenya staff also support a local program for helping adults attain their secondary school graduate certificate. Education efforts are further supported by the bridging of our two cultures through our International Visitation Program where volunteers from developed nations travel to Kenya to engage with the students, teach at the schools and provide professional support based on their expertise, and our Awareness Program where volunteers provide presentations to school children and community groups in the US, sharing ideas, information and Kenyan culture to raise awareness and bring our worlds closer together.
