This program gathers research and data on the link between runaway and homeless youth and uses it to inform specialized trainings and materials for Family Youth Services Bureau Programs including Basic Center Programs, Transitional Living for Runaway and Homeless Youth, Family Violence Prevention Services, and Adolescent Pregnancy Prevention. During 2018 GC assisted in creating E Learnings on Labor Trafficking and Commercial SEXual Exploitation as it is encountered in RHY, a Resource Guide on Identifying Trafficking and Responding Appropriately for RHY Grantees and others in the RHY community, a Blueprint for Action on Trafficking for family youth services programs, and a basic Human Trafficking Toolkit of materials for use in homeless shelters and other related kinds of services for runaway and homeless youth. In addition, GC is advising on trainings, technical assistance and other resource materials to help integrate human trafficking into FYSB's programs

In 2018 Global Centurion expanded our work on the health consequences of trafficking to include a series of projects that focus on the gynecological, reproductive, and procreative issues associated with human trafficking. Under this rubric we developed a series of Online and In Person Trainings for Pregnancy Resource Centers (PRCs) and Pregnancy Helping Organizations (PHOs). We also participated in several intensive trainings at various annual conferences to assist in the development of specialized materials on pregnancy and its outcomes in trafficking. These included a series of videos of survivors describing pregnancy during trafficking. We began working with a variety of service providers who provide family planning, pregnancy, and related services to assist them in gathering information, developing trainings and materials for their providers, and in information gathering sessions such as Key Informant Interviews to help develop programs focused on these communities

GC teamed up with The Woodson Center, another US non-profit organization, for a project, Preventing Trafficking in Foster Care by Creating Private Alternatives to State-Run Foster Care. The project has as its main deliverable an Inventory of community and faith-based organizations that are already engaged in innovative approaches and alternatives to foster care, adoption and family support efforts with proven track records. Special emphasis is being placed on efforts in communities of color and other new culturally sensitive approaches developed in the last decade are initiatives
