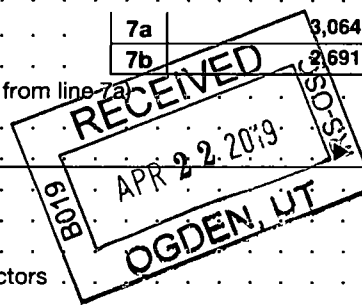

In 2018, 64 league members benefited from FoCo Roller Derby athletic training services. There are four practices per week on average; it is estimated that there are 176 opportunities for practice per year from January through December.

**30 Event Production.** FoCo Roller Derby holds events open to the public called 'bouts.' These bouts, or games, provide opportunity for our members to exhibit skills gained during member practice, and spectators to watch athletic roller derby competition.

On average, 20 members participate in the event and 130 spectators purchase tickets for a bout. In 2018, 915 spectators attended seven (7) bouts from February through December. Holding these events is key to our mission statement and allows us to generate funds necessary to pay for venue rental used for practices.
