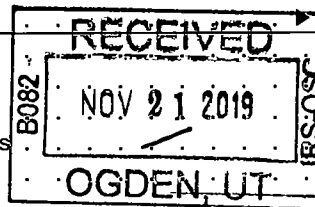

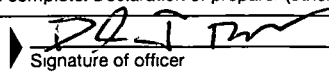

Grant paid of \$118,960 break down into three categories. Hardship grants which are awarded to families that are suffering from financial hardship due to breast cancer treatment that total \$116,240. Grant sizes are determined based on financial needs and set based on actual expense being incurred by the family. Grants ranged from \$500 to \$3,000. A total of Fifty-four hardship grants were awarded in 2018.

The second category is a yearly scholarship that is awarded to a student that has a parent or guardian affected by breast cancer. Each year a new student is awarded a 4 year renewable \$500.00 scholarship. Each year a total of \$2,000 in scholarship money is awarded 1 new scholarship and 3 renewals from previous winners. The third category are well wishes, which are small packages of flowers or edible arrangements that are given to women recently diagnosed or in treatment for breast cancer. The packages are designed to brighten the spirits of the women and families that might not necessarily have a financial hardship from their illness. The Well wish packages range in cost from \$49 to \$150. Nine packages were awarded in 2017 for a total of \$720.

Other expenses of \$33,711 are all fundraising expenses from two main events that are used to raise the vast majority of the foundation's revenue. A charity ball with a silent auction that takes place in the winter (generally Q1) which accounts for \$27,777. And a 5K run/walk race that takes place in the summer (generally Q3) which accounts for \$5,934

Total Liabilities of \$2,500 are from awarded scholarships. Each year a scholarship is awarded and it is a renewable four year scholarship the pending payments are accounted for as liabilities
