We offered nine in-school programs covering topics from insects, bats, birds, frogs, mammals, and geology, reaching 2807 students over 121 individual programs. We presented 83 field trip programs, reaching 2506 students. Field trip programs included bird banding, winter wildlife survival snowshoe outings, geology of the Sierra Nevada, and various science programs conducted at the Sagehen Field Station. We also reached 2402 students via clubs (e.g., Bird Club at Incline Elementary) and special educational events, and hosted 474 children over 22 nature camps.
