Baby DJ provided grants and in kind donations to other local nonprofits to support their charitable and educational activities. These efforts included the provision of backpacks and supplies to 10 Title I schools, all for distribution to their socioeconomically disadvantaged student bodies. In addition, we made non-cash grants to 7 local nonprofits with excess gifts in kind which remained after completion of our Christmas drive
