28 THE FOUNDATION AWARDED SCHOLARSHIPS TOTALING \$45,902 IN 2018 FOR THE 2018-2019 SCHOOL YEAR. THE SCHOLARSHIPS ARE DISTRIBUTED IN TWO PAYMENTS, IN AUGUST FOR THE FIRST SEMESTER AND IN THE FOLLOWING JANUARY FOR THE SECOND SEMESTER. THERE WERE TWELVE APPLICATIONS SUBMITTED TO THE FOUNDATION AND SCHOLARSHIPS WERE AWARDED TO SIX STUDENTS. APPLICATIONS FOR TWO STUDENTS WERE APPROVED, BUT THE PARENTS DECLINED THE SCHOLARSHIP SINCE THE AMOUNT DID NOT MEET THEIR FINANCIAL NEEDS. TWO APPLICATIONS WERE NOT COMPLETED, THUS THE APPLICATIONS WERE DENIED AND ONE APPLICANT WAS DENIED SINCE IT WAS DETERMINED THAT THE FAMILY DID NOT MEET FINANCIAL NEED CRITERIA. FOUR OF THE STUDENTS ATTENDED TWO DIFFERENT JACKSONVILLE, FLORIDA SCHOOLS AND TWO STUDENTS ATTENDED MCGLANNAN SCHOOL IN MIAMI, FLORIDA. THE APPLICANT'S SCHOOL MUST BE ACCREDITED AND MEET THE EDUCATIONAL NEEDS OF THE DYSLEXIC LEARNER. EVALUATION OF THE STUDENT'S COURSE WORK AND GRADES IS REQUIRED FOR CONTINUED SUPPORT SINCE SCHOLARSHIPS ARE FOR A ONE-YEAR PERIOD AND AN APPLICANT MUST RE-APPLY EACH SCHOOL YEAR. THIS PROVIDES IMPORTANT FEEDBACK ON THE STUDENT'S PROGRESS AND OVERALL SUCCESS OF THE SCHOLARSHIP PROGRAM. THE BOARD MEMBERS RECOGNIZE THAT MOST STUDENTS WILL REQUIRE MORE THAN ONE YEAR OF SPECIALIZED INSTRUCTION FOR REMEDIATION, THUS ADEQUACY OF FUNDS MUST BE CONSIDERED FOR ADDITIONAL YEARS.
