The Mercy Maternity House Inc. works with Rehema House Rescue Centre, a charitable foundation in Kenya. During 2018, an additional 6 pregnant teenage girls were rescued and all delivered healthy babies. From 2010 through 2018, the home rescued 48 girls and 45 babies. The girls all receive counseling, tutoring, skills such as hairdressing, manicures, sewing, and jewelry making as well as training in how to care for their babies. This program affected the lives of about 500 individuals.

The Mercy Maternity House Inc. believes in creating, operating and supporting programs that assist women, in impoverished circumstances in developing countries, to learn an artisan trade and create an avenue to provide for their livelihood. The ministry accomplishes this program through two avenues. The Fair Trade Friday program is 4 subscription clubs that empower artisans by selling their handmade product in U.S. and Canada. Mercy House Global currently works with 117 faith based artisan groups in 34 countries to empower mostly women artisans.
