THE GREEN SPORTS ALLIANCE MOVED FORWARD WITH ITS GOALS TO FURTHER GROW THE GREENING MOVEMENT IN 2018. BELOW ARE A FEW HIGHLIGHTS AND CHALLENGES OF 2018. THE ALLIANCE HELD ITS ANNUAL SUMMIT IN ATLANTA, GA FOCUSED ON SUCCESSES AND LESSONS LEARNED IN THE SPORTS GREENING MOVEMENT AND ATTENDEES LEFT WITH TANGIBLE TAKEAWAYS TO FURTHER PROMOTE HEALTHY AND SUSTAINABLE COMMUNITIES WHERE WE LIVE AND PLAY. THE SUMMIT INCLUDED 608 ATTENDEES, INCLUDING 141 SPEAKERS. ATTENDEE FEEDBACK WAS VERY POSITIVE, HOWEVER SPONSORSHIP DOLLARS CONTINUED TO BE SIGNIFICANTLY DOWN FROM PRIOR YEARS. SEE SCHEDULE O. ALTHOUGH WE SAW A DECREASE IN SUMMIT SPONSORSHIP DOLLARS, WE FURTHER STRENGTHENED RELATIONSHIPS WITH EXISTING PARTNERS. THEIR FUNDING SUPPORTED MANY NEW PROGRAMS AND RESOURCES TO MEMBERS THROUGHOUT 2018, INCLUDING 11 WEBINARS, AWARDED THE 2018 ENVIRONMENTAL LEADERSHIP AWARD AND 10 ENVIRONMENTAL INNOVATORS OF THE YEAR AWARDS CELEBRATING THE ACHIEVEMENTS OF THE SPORTS GREENING MOVEMENT, HOSTED A ENERGY WORKSHOP IN LOS ANGELES, AND DEBUTED THREE NEW RESOURCES: FAN ENGAGEMENT PLAYBOOK, PAPER USE PLAYBOOK, AND PLAYING FOR OUR PLANET. SUSTAINABLE SPORTS ALLIANCE MEMBERS, BOARD AND STAFF PARTICIPATED AND CONTRIBUTED TO THE CONTENT OF MANY 2018 INDUSTRY CONFERENCES, INCLUDING IAVM, AASHE, AND SMA. THE GREEN SPORTS ALLIANCE ADDED MANY NEW MEMBERS IN 2018, RAISING THE TOTAL NUMBER OF TEAMS, VENUES, LEAGUES, FANS, AND EVENTS TO NEARLY 600. THE ALLIANCE ADDED ADDITIONAL MEMBERS TO THE CORPORATE MEMBERS NETWORK, WHICH CONVENES BUSINESS LEADERS WITH THE GOAL OF PROMOTING ENVIRONMENTALLY-PREFERABLE GOODS AND SERVICES IN THE SPORTS INDUSTRY. 2018 HELD STAFFING TRANSITIONS AND RESTRUCTURING, INCLUDING SECURING A NATIONAL SEARCH ORGANIZATION FOR A NEW EXECUTIVE DIRECTOR, ELIMINATION OF THE EVENT MANAGER POSITION (OUTSOURCED TO A 3RD PARTY), AND HIRING A MEMBER SERVICES MANAGER. AT THE END OF 2018, THE ALLIANCE HAD THREE FULL TIME STAFF MEMBERS AND ONE PART TIME STAFF MEMBER. A NEW EXECUTIVE DIRECTOR WAS SECURED TO START IN JANUARY OF 2019. THE ALLIANCE ALSO ADDED SIX NEW DIRECTORS TO THE BOARD. MEMBER RETENTION FELL SLIGHTLY BUT SAW AN INCREASE IN NEW MEMBERSHIP IN THE YEAR. SPONSORSHIP ON THE OTHER HAND, HAS SEEN REDUCED RENEWALS AND RENEWAL AMOUNTS. AGING A/R REMAINED HIGHER THAN DESIRED IN 2018, AS A RESULT OF CHALLENGES COLLECTING MEMBERSHIP DUES AND SPONSORSHIP FUNDS IN A TIMELY MANNER. HOWEVER, IT HAS REDUCED FROM 2017. CONSEQUENTLY, THE ALLIANCE HAD TO WRITE OFF \$25,500 IN UNPAID INVOICES FROM 2017. A STRATEGIC PLANNING SESSION AND BOARD RETREAT WAS HELD IN 2018, TO FURTHER FOCUS ON OUR ORGANIZATION'S STRUCTURE AND GOALS MOVING INTO 2019. THE STRATEGIC PLANNING SESSION ALSO FOCUSED ON STRATEGIES FOR DECREASING AGING A/R, IMPLEMENTING TIMELY COLLECTION PROCESSES, AND REFOCUSING OUR MEMBER VALUE PROPOSITION. IN ADDITION, THE FOLLOWING PARTNERS WHO, THROUGH THEIR GENEROSITY, HAVE DONATED IN-KIND RENTS OR SERVICES TOWARDS OUR MISSION: GREEN BUILDING & DESIGN - \$13,000, MEDIA PROMOTION FOR 2018 SUMMITINNOVATION & TECH TODAY - \$15,000, MEDIA PROMOTION FOR 2018 SUMMITPANSTADIA - \$10,860, MEDIA PROMOTION FOR 2018 SUMMITBIOCYCLE - \$13,000, MEDIA PROMOTION FOR 2018 SUMMITREAL LEADERS - \$15,000, PROMOTION FOR 2018 SUMMITTERRACYCLE - \$1,000, RECYCLING SERVICES FOR 2018 SUMMITGREEN GUY MEDIA - \$1,000, MEDIA PROMOTION FOR 2018 SUMMITLNS CAPTIONING - \$4,625, WEBINAR CAPTURING SERVICES FOR OUR ANNUAL WEBINARS FOR 2018 SUMMIT.
