The program also encompasses an anti-bullying campaign. From ICTC, a Teen Huddle derived, an auxiliary group of about 20 teen volunteers with a mission to "Raise Autism awareness and acceptance among teens." The teens host two programs, in partnership with a local church: 1) Parents Time Out (PTO) 2) Sibling Sessions (SS). PTO provides parents with three-hours of respite while teens and church volunteers entertain all children in the family. SS, teen mentors are paired with the sibling of a child with Autism, to develop friendships and encourage support through a variety of activities. All programs are free to families.
