Family support initiatives included facilitating an equipment exchange program for families to share medical equipment they are no longer using. Additionally, families received support via multiple online support groups and educational mailings. In 2018, we hosted 2 webinars for patients and caregivers and also piloted a parent-to-parent support program offering families an opportunity to speak directly with another family that has experience with a peroxisomal disorder. Finally, we provided patients and caregivers with direct access to our Scientific Advisory Board via email and phone calls and advocacy to assist families in understanding the symptoms and progression of disease of peroxisomal disorders

In 2018, the GFPD supported research funding aimed at getting treatments from the laboratory bench to the patient’s bedside as quickly as possible. We supported the development of a metabolomics resource for peroxisomal biogenesis disorders in the Zellweger Spectrum as well as Rhizomelic chondrodysplasia punctata and the related single enzyme deficiencies like D-bifunctional protein deficiency and Acyl Co-A Oxidase 1. We continued to support a multi-year project to develop research resources for neurodegeneration and vision loss in peroxisomal disorders. We also continued to promote the retinal gene therapy project that we funded in 2017 and continued to push ahead drug testing of candidate drugs through the use of mouse models, as well as an assay development and screening project at through a postdoctoral fellowship at the National Center for Advancing Translational Sciences, using high-throughput drug screening to uncover therapies for children with PBD-ZSD.
