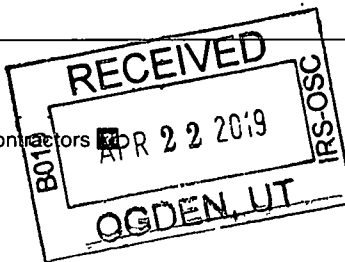

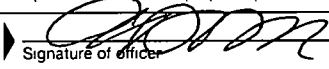

EXPENSES - Explanation of Grants - We provided education and development grants to 7 communities located in the country of Ecuador.

All our grants come directly from program fees that we charge international students and volunteers, all of whom are college students in the USA. The students participate in study trips to Ecuador and a portion of their fees finances a grant to carry out a community project. In exchange, the communities provide Room/Board to the students/volunteers during their time in country.

A. Communities of Machankara and Nina Shunku: Located in the capital city of Quito. Total investment: \$17,830. Two projects.

Project 1: Communities and students conducted research and led educational events with the goal of empowering the communities as a whole to seek remediation of the contaminate Machangara River. **Project 2:** Communities and students studied gender conflicts in the hip hop community of Quito and made a video to assist in opening communication. See 990 for amount of beneficiaries.

B. Community of Tzawata: Located in Amazon region of Ecuador. Total Investment: \$5,536. Community members and students worked on two projects, both of which were agricultural: a medicinal plant garden, and a combined reforestation/vegetable garden project. See 990.

C. Community of Pintag. Located in the Andes mountains of Ecuador. Total investment: \$2,670. Community members and students worked on agricultural projects including a seed bank, permaculture farm and hydroponic animal feed system. See 990 for amount of beneficiaries.

D. Association of Union de Afectados por Texaco. Located in the Amazon region of Ecuador. Total investment: \$2000. Students and community members worked on the associations 25th anniversary event, providing funds an support to educational/research events/activities. 24 community members attended the focus groups and 250 attended the educational activities.

E. Community of La Mariscal. Located in the Amazon Region of Ecuador. Total Investment: \$1,625. Community members and students worked on developing the community's tourism collective, providing educational workshops to community members and assisting in developing activitiies to carry out with tourists. Over 30 community members participated.

F. Community of Bavoroe. Located in the Amazon region of Ecuador. Total investment: \$500. Community members and students worked on documenting two oral traditions from the community. The traditions were recorded and shared with the community at large. A total of 75 community members participated in the final event.

EXPENSES: Other expenses.

A. Travel expenses for students and volunteers. \$8,508 - This includes the costs of transporing students to the communities and all their expenses when not in the partner communities, including additional food, lodging and cultural activties.

B: Matierals. \$1,362. This includes the supplies that we purchase in order to carry out the educational programming during the projects.

C. Promotional trips. \$3,247 This includes all our travel expenses to colleges in the USA where we promote our programs.
