To that end, the Foundation makes the information in the database available to physicians, surgeons, researchers, healthcare providers, and others in connection with medical and scientific research and the treatment of children receiving heart transplants. This information is also available to support quality improvement metrics for the transplant centers and to help the centers to develop best practices and procedures for caring for children after heart transplant.
